Meeting purpose:

To discuss potential re-alignment options for Gatton–Clifton Road as part of the Mount Whitestone business case with potentially impacted property owners in the study area.

Meeting notes:

- DK shared the short-list of options to realign Gatton-Clifton Road (Figure 1). T&DH' property is not impacted (land requirement) by any of the short-listed realignment options.
- per disagrees that their property is not impacted.
- AK explained that 'property impacts' refers to land requirement for the transport corridor eg.
 eventual resumption but acknowledged that all options have impacts to their home /
 property from moving a busy road closer. We are consulting to understand potential
 impacts and property owner preferences.
- From the previous meeting TMR project officers understood that option that crossed their property and Refuse Sch. 4, Part 4, s.4(1)(b) Disclosing deliberative proposed options so that their property might be resumed. T&DH said that they would not want to live in their current location if Gatton-Clifton Road Refuse Sch. 4, Part 4, s.4(1)(b) Disclosing deliberative processes
- DK explained why it is not feasible for an alignment to go through their property, including
 the significant grade, proximity to the active area and the land on the eastern side of Ma Ma
 Creek to which the road / bridge would connect is on an old landslip which is unsuitable for
 building roads and bridges.
- Refuse Sch. 4, Part 4, s.4(1)(b) Disclosing deliberative processes and the potential impacts on their property and home during construction and operation if Gatton-Clifton Road Refuse Sch. 4, Part 4, s.4(1)(b) Disclosing deliberative processes
- per shared that they would be seeking to object to option A being selected as the preferred realignment option.
- DK explained that the purpose of consultation is seeking property owner feedback to help inform the prioritisation of the short-listed options. And person preference and reasons will be considered as part of planning.
- aid he would like to seek the advice of a consultant and generate a formal submission regarding the impacts from the realignment options, particularly option A, and asked for a copy of the consultation plans.
- CH explained that we do not provide a copy of the consultation plans.
- per took a photo of the consultation plans.
- AK explained that could explain to a consultant for the purpose of developing a submission that option A could be described as relocating Gatton-Clifton Road states are not yet developed but as more detailed designs are not yet developed it would still be general rather than detailed feedback. All options have impacts. We are gathering property owner implications with each alignment, to help inform the prioritisation of the options. AK suggested it may be too early in the process to develop a detailed written submission.
- AK suggested that the project is required to investigate noise impacts, and that DK and AK would encleavour to share the specific requirement for noise modelling/investigations during this stage of planning understanding that more detailed noise modelling is more likely undertaken in later phases of a project, if/when there is funding for detailed design/construction to inform/avoid perhaving to complete (pay for) work independently that is intended to be undertaken as part of the project.
- explained he did not wish to miss his opportunity to influence the realignment option selection and intended to develop / submit their objection.
- AK acknowledged TH preference to avoid option A, and desire to provide more information / reasons for TMR not to progress that option.
- CH explained the planning process and corridor protection generally.

- DK explained that TMR is still (more enthusiastically) investigating options to maintain Gatton-Clifton Road on its existing alignment.
- DK explained that TMR will be using property owner feedback and other investigations to prioritise the realignment options, and following more detailed investigations on options for the existing alignment will be engaging with property owners again, aiming for Easter time. At least to contact and provide a project update.
- AK reiterated TMR would investigate and provide further details to TH on the requirements for noise modelling as part of the business case.
- DK invited persoto contact us anytime with any further questions or feedback about the project.

Follow up actions (TMR):

- Provide details of the noise modelling / investigation required in the business case / planning phase.
- Meet again in 2024, potentially around Easter time, to provide update of project progress.





"Meaningful" in this context surely means that a layperson such as myself can draw upon subject matter experts, at my own expense, to provide expert advice on the department's realignment options by way of a formal submission and have that submission inform the department's realignment option deliberations.





I refer to your email of 6 January 2024 to the Honourable Bart Mellish MP, Minister for Transport and Main Roads and Minister for Digital Services, about the Gatton–Clifton Road realignment planning project, Mount Whitestone. The Minister asked that I respond on his behalf.

As noted in previous correspondence and face-to-face meetings, the Department of Transport and Main Roads' (TMR) investigations to mitigate the affected, and at-risk section of Gatton–Clifton Road is due to large and slow moving land slips at Mount Whitestone are preliminary, and realignment options are conceptual at this stage.

TMR is undertaking targeted consultation which will inform a business case for this project. The aim of a business case is to investigate and develop a preferred option which considers the transport needs of the community, safety, cost, potential land requirements, impacts on property owners, businesses and the environment. When a business case is completed, the recommendation/s are assessed by the department, and an informed decision is made on how the project may proceed, protect a transport corridor and/or seek investment for design and construction.

In general, TMR does not publicly release detailed options at this early stage of a planning project, for a number of reasons including:

- TMR's Approved Planning Policy outlines if planning documents are used in external discussions, it is important the owners of the affected land are aware of the planning and its status.
 - Concepts developed in planning are likely to change due to a low degree of certainty in the options due to investigations just commencing, as such, if planning documents are made public and subsequently superseded, it may lead to misunderstanding with potential detrimental impacts for property owners and the community.

 As consultation is underway with key stakeholders and potentially impacted property owners, the information shared and discussed is considered sensitive and private.

I am advised that TMR has undertaken face-to-face consultation with property owners at Mount Whitestone and gained valuable insight into potential property impacts and the community concerns that may result from a realignment of Gatton–Clifton Road.

There is no intention to publicly release layouts or details of short-listed realignment options for this project during the business case phase. They have only been shared in private meetings with key stakeholders, and potentially impacted property owners like yourself.

I can assure you that TMR will continue with our targeted consultation so that key feedback informs our investigations. TMR will also seek to consult with you and other potentially affected property owners, before progressing a preferred option to be recommended in the business case.

Dear Minister,

Thank you for initiating a response from your department (Ref: MC142585) to my correspondence of December 19.

With respect, it is disingenuous of TMR to have advised your office that "feedback is being sought from key stakeholders and potentially impacted property owners" when TMR has not released any information regarding the options they are investigating.

In the absence of what I would regard as even a modicum of transparency around their investigative processes, it appears to me that there is a very real possibility that TMR will settle on their preferred route without stakeholders such as myself being afforded the opportunity to review and comment on the routes TMR currently has under investigation.

In order to dispel my concerns and those of my near neighbours who will be impacted to a greater or lesser degree by this decision, would the Minister please advise whether TMR:

- 1. Will publically release a "short-list of options" for the Gatton-Clifton Road realignment planning project now under consideration prior to any decision being made by TMR as to their preferred route?
- 2. Provide potentially impacted residents such as myself an opportunity to provide feedback on the short-list of route options once publically released before TMR moves to finalise their preferred route?
